HAPA Members,

The June BOD meeting was held at **Rich Rudolph's** hangar, Tuesday June 14, 2005. My thanks to Rich!

The next BOD meeting will be on the second Tuesday July 12th, at 7:00 PM. I invite all HAPA members to come and be part of the process.

I'm happy to report that the signs that are going up and the new speed limit seem to be having a positive effect. I thank all the membership for their cooperation and again remind you to inform your visitors/renters/guests of the rules and regulations that HAPA members are responsible for.

The major concern voiced by the members attending June's meeting were the few members who want to ignore the CCR's and By-Law's and violate the rights of all members to free access of the **Taxiways**. It is not the BOD's wish to levy fines or order our towing company to remove the blockage. However, we will, if a member by their actions **forces** us to do so. **This is an airport. Aircraft have the right of way. Blocking a taxiway and forcing an aircraft to wait, shut down or alter their direct access between the runway and its hangar, is a violation.** Why you may ask? First and foremost it is one of the most important rules that you agreed to when you purchased your property at Hick's Airfield. Second, as most of you are aware, almost all aircraft are air-cooled and will overheat if delayed in taxiing or forced to take a longer route. This can result in extensive damage to the engine costing up to \$30,000.00 or more to repair. I ask all members to not block the taxiways and compel us to impose fines and/or tow. Ultimately the decision and compliance are up to you, the HAPA member.

On a more positive note, the **Runway/Taxiway fund**

has reached almost \$200,000.00 and your BOD is starting to work on the new runway specifications. Any member desiring to be on the runway committee, please contact me at 817-439-0614 or by e-mail at viking736@yahoo.com.

We had a taxiway-patching party on Friday June 17, 2005. MONTHLY SAFETY TIPS

GOLF CART SAFETY

With the summer months upon us, there has been an increase in the use of personal golf carts as a means of on-airport transportation. Golf carts are involved in a number of accidents, resulting in personal injury, death, and property damage each year. To prevent accidents, everyone should follow a few simple safety precautions while operating golf carts.

- * Drivers and passengers must remain seated while the vehicle is moving
- * Allow only properly trained persons to operate the vehicle
- * Never exceed the number of available seats for the number of passengers
- * Slow down and/or stop at all intersections
- * Reduce speed when approaching other vehicles or pedestrians, yield the right-of-way
- * Reduce speed when turning
- * Do not park carts where they will block entrances, exits, intersections, or the normal flow of Traffic
- * The maximum speed of a golf cart depends upon the terrain over which it is being driven, the Weather conditions, and the total weight of the cart, passengers, and equipment being carried
- * A golf cart should be operated at a speed equivalent to a well-paced walk, but no faster than 15 MPH
- * Observe all Texas traffic laws, such as lane of travel, stop signs, and legal passing
- * All passengers should keep hands, arms, legs, and feet within the confines of the cart at all times
When in motion
- * When the golf cart is not in use, set the emergency brake, put the control lever in the "neutral" Position, and remove the key
- * Never leave the keys in the cart when unattended
- * Never back up without looking behind the vehicle first
- * When driving, maintain adequate distance between vehicles
- * When operating at night, always use lights

Always use caution and common sense when operating your golf cart on the airfield so accidents can be avoided!!

The monthly safety meetings are going to be postponed during the summer months due to the busy schedules of most everyone. If anyone has a safety issue, feel free to contact me via my email and I will attempt to address your concern.

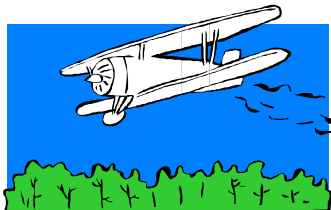
