Rio concho fl ying contest

A great time was had by all at the annual Rio Concho Spring Precision Landing and Bombing Contest. Kevin and Barbie Brunson hosted the event again this year on June 6th. Several local pilots showed up to try their hand at landing and water balloon bombing. Gusty winds were kicking up to make the spectacle a real crowd pleaser for all who attended. The landing contest required landing on or after the threshold line for runway one-four. Lines marked in twenty-five foot increments afterwards narrowed down the measuring process for the volunteer judges. Despite gusty conditions a three way tie resulted after three planes managed to land directly on the line. A fly-off was held to see who received the coveted Best Landing bragging rights. 3rd place went to Bob Reed in his Bonanza, 2nd place to yours truly in my Cessna 172, and 1st place and all the prestige that goes with it went to **Allan "Bounce" Corbaley flying a Cessna 172 of questionable origin.**

The bombing contest was a departure from the old days of using flour filled bags to the more challenging and sensitive ordinance of water balloons. This ammo required careful handling since each pilot only received one balloon for each of two passes allowed. Any balloons going off in the cockpit would of course be lost. As this newsletter cover photo shows, Billy Aiken received a muddy shower when a bomb hit within a couple of feet of him while judging the contest. One can only speculate as to how the bombardier could have missed the target by so far...*or did he?* The results came close to **matching the landing contest as Allan "Bounce" Corbaley once again took top honors. 2nd place to myself and Bob Reed as bombardier, with 3rd place going to Nate Abel and a gal he didn't know that he grabbed out of the crowd for bombardier!**

The prizes this year were fantastic, and given current fuel prices, quite valuable as well! 1st place in each event received 25 gallons of Avgas. 2nd place received 15 gallons, and third place received a Rio Concho hat and one of their famous Bonanza Burgers.

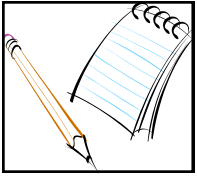

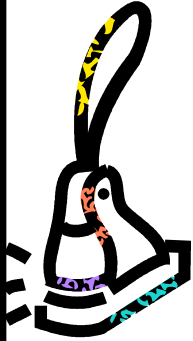
