Presidents Corner

Fellow Members,

We had another well attended Board meeting on the 14th day of May, 2009 at the Avery's Hangar (Many thanks to Bob & Judy Avery for allowing us to impose on them.)

The Board was visited by the local Homeland representative who stressed airport security and how, in their opinion, to address it. It reminds me of how we protect our homes. We lock our doors when we are not at home. We fence our yards, some of us even do security cameras, electric gates, etc. **It's not complicated. The same things you would do in a traditional home, you should do here for your hanger at Hicks Airfield.** Obviously the flight schools, students, and instructors are the subject of security, as they should be post 911.

Your Board of Directors is considering additional scrutiny in order to make the west and south-west ends of our airport more safe and secure. We have fence along the south, east and north ends which may need repair or re-design. It should be noted that none of these are big ticket items.

Several issues concerning ONCOR and the re-design of power poles, Tarrant County Appraisal District appraisals, electric bills and drainage were all discussed at length. Additionally, several delinquent accounts that are heading toward possible foreclosure were discussed. Some of these were tabled in preference to attempt settlement with the owners.

Security and safety issues are now mainly parked cars on or near taxiways, dogs at large (i.e., **not on leashes**), and materials stored where they should not be. **Don't be surprised to hear from P.M.G.** (fines should not be necessary, -simply follow the rules, please.)

As we move into the summer months please let any of the Board of Directors know if you see or **have a problem that you can't handle with a "hand shake."**

You will need to be present on the day of the work so that you may direct exactly where you would like the fill placed.

These are just a *few* of the roughly twenty women pilots who call Hicks their aviation home. Pictured from left to right are: Carol Morris, Jane Hertel, Barb Allred, Jessica Buchert, Penny Miller, and Carol Beard.

Carol Beard is our newest pilot. If you have been around lately, you have seen her overhead in a C-150, wind and rainy weather notwithstanding. Carol trained a year and a half with stops and starts along the way, and already has over 200 take-off and landings. But now, at age 61, Carol has her private ticket. We asked her if she has flown with any famous people, and she said "Yes – Jay Pratt"!

Jessica Buchert lives at Hicks and has been flying for a little over four years. She earned her private pilot's license from SkyMav's at Meacham Airport in just 41 hours. She and her husband Kurt came to Hicks through Mr. Mark Miller. Mark was such a help with their first aircraft, a 1965 Beechcraft Musketeer, and such a great ambassador for Hicks that they just decided to put down roots and stay.

Penny Miller lives at Hicks and flies a 1948 Cessna 170. She is a seasoned private pilot who started flying in 1977 at Amelia Reid Aviation in San Jose, CA. Penny and her husband, Eric, have owned and enjoyed flying Stinsons, a Bellanca, a Cruisemaster 14-19, and are now building a Bearhawk, all taildraggers.

Carol trained at Garland Airport in Dallas and earned her private ticket in August of 1967. She has time in retractable, twin, helicopter and hot air balloons, but took a twenty year break that ended in 2005 when she started flying an RV7-A that she helped build. She was a Founding Board Member and organizer of the Texas Pilots Association, and is currently a trustee of the Museum of **Women Pilots in OKC for the 99's.**

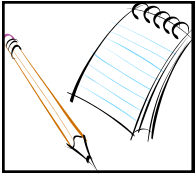
The Choctaw

BoD Meeting MINUTES

A regular meeting of the Hicks Airfield Pilots Association Board of Directors was held on April 9, 2009 in Hangar 111. A quorum being present, the meeting was called to order at 6:34 p.m. and announced ready by President Gene deBullet.

Board members present President Gene deBullet, Don Browning (Secretary), Jim Usher, Ted Kelso and Bob Avery. Other members of the Association were also present as observers.

Treasurer, Jim Usher submitted his report to the board, motion approved and seconded by Don Browning. Secretary, Don Browning had nothing new to report to the board. Don Browning read the minutes from the previous board meeting, Ted Kelso moved to approve as read and Bob Avery seconded the motion, abstained. Changed minutes; added Security to Courtesy. Sprayed for gas and weed control.

Reports of Committees

Stuart Davis in absentia.

Robert Avery had nothing new to report.

Larry Partain – Jim Usher would like a copy of the report prepared by Larry Partain. Board discussed no longer renting a golf cart. Motion made by Ted Kelso and seconded by Don Browning. All were in favor; unanimously passed.

Board discussed Hanger 243 – Indebtedness. Offer approved \$5,000.00, re-deed to owner, with one week window; moved by Bob Avery, seconded by Don Browning.

Discussion as to various complaints, Hangar 146/141, taxiways damage repaired at no cost, and getting bids on south gate from security standpoint.

Hangar 146 – Owner, Dr. Paul Blakely

Hangar 141 has been storing things outside (has pictures)

Hangar 146 went to Hangar 141 to discuss.

Other issues: People continue to park on taxiway.

President Gene deBullet “pictures indicate there is a problem.” Larry Partain to handle within 24 hours.

Paint booth is owned by Mr. Lloyd Marks of Louisiana. Extensive conversation on this matter. President Gene deBullet asked Bill Schoengarth (DynCorp) to have it handled within 24 hours.

Bill spoke directly with Jim Usher explaining the situation. President Gene deBullet indicated that Bill Schoengarth will handle this; will table this. Larry Partain commented that there should be posted that people can come to him in these instances. Post it in Flappings, infractions (warnings.) Ron Sinclair will place in Flappings.

Further discussion by member Ron Sinclair as to his concern about golf cart/security vehicle. Board discussed the CCR’s terminology and use of the word security as it was explained by Don Browning.

Also discussed was the airports tax exempt status. Jim Usher mentioned the tax “audit?”

Don Browning brought the board attention to Mike Olsen who was present and commented, (646) patchwork by Cal’s folks, maybe a water issue or forklift issue. Mike Olsen will contact Larry Partain and vice versa. Also mentioned was the gravel issue; heavy machinery and gavel. Per Don Browning, the owner is amenable to getting issue resolved. For Security issues contact Larry Partain. For taxiway problems, call Mike Olsen.

Don Browning asked about the Architectural control committee, which was approved. (Ask President Gene deBullet about this.)

Larry Partain expressed his concerns, i.e., vehicles being parked in a lot where a hangar is about to be built, stray dogs and car drags. Carol Moran is taking care of this with letters.

Vehicles on lots, stored behind hangars, north end etc. near tracks.

More complex issue, owned by railroad.

Larry Partain adds that they will get towed after their first warning.

Carol Moran comments, “Towing is good.”

Motion to adjourn the meeting made by Ted Kelso and seconded by Don Browning. Meeting adjourned at 7:05 p.m.

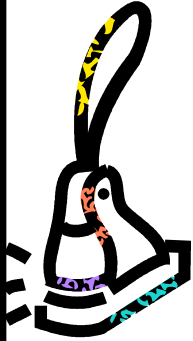
